STANDARDS COMMITTEE **TERMS OF REFERENCE**

MEMBERSHIP:	As determined and appointed by the full Governing Body
QUORUM:	3 Governors
MEETINGS:	6 times a year – plus as required using the Terms of Reference as a guide to Agenda setting

The Clerk and/or Chair to the Committee will be responsible for arranging the meetings, taking notes, typing up and distributing draft Minutes and chasing actions.

The Committee to have the power to make its own decisions without referral to the full Governing Body, except where specified below or where the subject matter requires full Governing Body consideration by law.

RESPONSIBILITIES

In conjunction with the Headteacher the Committee will have the following responsibilities:

- 1 Monitor and evaluate the effectiveness of the curriculum provision in raising standards and ensure it adheres to the National Curriculum
- 2 Ensure that robust data tracking tools are in place for all year groups and evaluate the use of data analysis and tracking systems on outcomes
- 3 Monitor and evaluate RAISEonline data, Assessment for Learning (AfL) and the quality of learning and pupil progress by curriculum areas, year groups, gender and other criteria eg Black and minority ethnic (BME), children in care (CiC), gifted and talented (G&T), children with special educational needs (SEN), children with additional educational needs (AEN), children eligible for free school meals (FSM), young carers (YC), children with English as an additional language (EAL), and where appropriate, ensure the school sets realistic but ambitious pupil performance targets by 31 December each year
- 4 Monitor and evaluate the effectiveness of leadership and management in driving and securing improvement
- 5 Review, approve and monitor the implementation of the school's SEN Policy
- 6 Review, approve and monitor the implementation of the school's agreed syllabus for religious education (RE) and the daily act of collective worship
- 7 Monitor and evaluate the effectiveness of the school's provision for developing pupils' knowledge and understanding of the world of work and developing skills and personal qualities which will contribute to their economic well-being
- 8 Review, approve and monitor the implementation of the school's Sex & Relationships Education Policy
- 9 Review, approve and monitor the implementation of the school's learning and teaching policies
- 10 Review September admissions and number on roll including transfers in/out
- 11 Ensure the Governing Body is represented at School Improvement Adviser discussions and resulting reports are presented, discussed and acted upon by the Governing Body
- 12 Identify and celebrate pupil achievements
- 13 Monitor and evaluate safeguarding, care guidance and pupil support procedures particularly in relation to vulnerable children including children with special educational needs (SEN), children in care (CiC), young carers (YC) and Black and minority ethnic (BME) pupils
- 14 Monitor and evaluate pupil attendance including setting targets by 31 December each year
- 15 Monitor and evaluate pupil punctuality including strategies to promote and support good timekeeping
- 16 Monitor and evaluate the effectiveness of the school's partnership links with other providers, organisations and services to promote learning and well-being

- 17 Monitor and evaluate the quality of the school's provision for pupils' spiritual, moral, social and cultural development
- 18 Monitor and evaluate the effectiveness with which the school encourages pupils to adopt healthy lifestyles
- 19 Review and monitor racial/homophobic and bullying incidents and the effectiveness with which the school promotes equal opportunity and tackles discrimination
- 20 Review, approve and monitor the implementation of the school's Behaviour Policy including a reward and sanction system
- 21 Monitor and evaluate exclusions by age, gender, ethnicity, whether the pupil has a statement of SEN, is being assessed for a statement, or is on School Action or School Action Plus and whether in Local Authority (LA) care
- 22 Monitor and evaluate the effectiveness with which the school promotes community cohesion and develops pupils' understanding of their own culture and those of others locally, regionally and nationally; and the extent to which pupils take on responsibilities and play a part in the school and wider community
- 23 Review, approve and monitor the implementation of the school's child protection, safeguarding and pupil related policies
